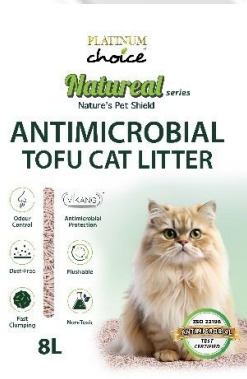


Figure 1: Product Packaging design

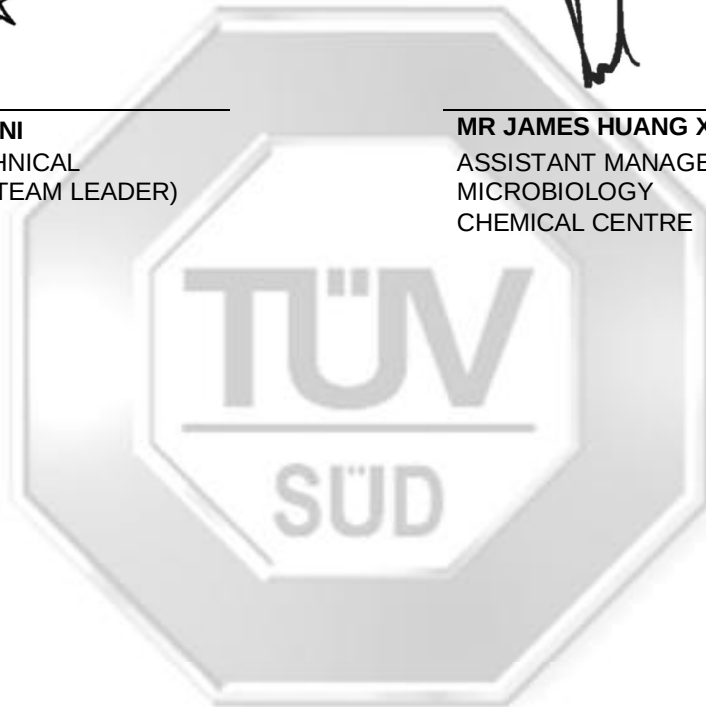
